**Running Order: Novice T1 and T2, Open T1 and T2, Senior T1 and T2, Master T1 and T2, C8 T1 and T2,**

**Doors open at 7:30, Briefing at 8:15, First dog on the line at 8:30**

**Ring Description:** The indoor ring consists of white lattice enclosed by PVC frames. The fencing is in both 4' and 8' sections. One wall of the building is used as part of the ring. The floor of the barn hunt ring is matting.

**Blind Description:** The blind enclosure is built with tarps and pvc. It consists of visual barriers on three sides. It is located approximately 25' away from the ring off to the side in the building.

**Handicapped Accessible:** Yes, however the parking lot is gravel and there is a small step up to the door that is several inches high.

**Classes Offered and Entry Fees:** Instinct \$18; Novice \$20; Open \$20; Senior \$25; Master \$25; Crazy 8 \$25

**Day of Show Entry Fees: (Please contact us the day before to ensure space is still available for your dog.)**

Instinct \$20; Novice \$25; Open \$25; Senior \$30; Master \$30; Crazy 8 \$30

**Move ups permitted if room is available**

**Bitch in Season Instructions:** BIS will run at the end of each level/class entered regardless of height. BIS must be crated separately from other dogs in a isolated area. A "BIS" sign must be affixed to the crate or displayed close by the crating area. Owners of the BIS must inform the trial chair of their status as soon as possible, prior to the event if known, or the morning of the trial so the running order can be adjusted. BIS MUST wear pants at all times when out of their crates except when being pottied. Potty areas should be separated from other dogs at the trial.

**Ribbons:** Class and Titling ribbons will be offered. Please let the trial chairman know if you will be earning a RATCH or a RATCHX.

**Refund Policy:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee. A full refund will be issued in the event of a major medical occurrence. Written notification must be given to the trial secretary at least 1 hour prior to the start of the first class the day of the trial. The Trial Committee may require additional written documentation prior to the issuing the refund.
