WAIVER, RELEASE, AND INDEMNITY AGREEMENT

In consideration of permitting the undersigned to participate in the dog training and dog competition activities of the Paw Power Blues Dog Club, an Illinois Not-For-Profit Corporation, the undersigned does hereby agree to the following:

- 1) The undersigned agrees to abide by the rules and regulations of Paw Power Blues Dog Club, Inc.
- 2) The undersigned agrees that Paw Power Blues Dog Club, as hosting club, reserves the right to refuse training or participation in any event for any cause which its officers and/or members deem sufficient.
- 3) In consideration of the acceptance of the undersigned and his/her dog/dogs for training for or participation in, classes, competitions, trials, seminars, exhibitions, social activity or any event, the undersigned agrees to hold Paw Power Blues Dog Club, its members, directors, governors, officers, agents, the owner or lessor of the premises, and employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person, property, dog/dogs or thing the undersigned or the undersigned's dog while in or upon any equipment or while training; participating in classes and events; or competing on the premises, grounds or near any entrance thereof.
- 4) The undersigned agrees to hold the aforementioned parties harmless from any claim for loss of the undersigned's personal property or dog by disappearance, theft, damage or injury caused or alleged to be caused by any other person or any other cause or causes.
- 5) The undersigned hereby assumes the sole responsibility for and agrees to indemnify and save the aforementioned parties harmless for any and all loss and expenses (including legal fees, court costs and related expenses) by reason of the liability imposed by law upon any of the aforementioned parties for damage sustained by any person or persons, consequence of the undersigned's participation in classes, competitions, trials, seminars, exhibitions, social activity or event, however such injuries, death or damage to property may be caused, or alleged to be caused, by the negligence of the aforementioned parties or any of their employees or agents or any other persons.
- 6) **IT IS THE SPECIFIC INTENTION OF THE UNDERSIGNED, BY SIGNING THIS DOCUMENT, TO EXEMPT PAW POWER BLUES DOG CLUB AND ITS DIRECTORS, GOVERNORS, MEMBERS, OFFICERS, AGENTS AND EMPLOYEES FROM ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, WRONGFUL DEATH TO THE UNDERSIGNED OR HIS/HER DOG/DOGS, CAUSED BY NEGLIGENCE. BY SIGNING THIS DOCUMENT, THE UNDERSIGNED ACKNOWLEDGES THAT HE/SHE ASSUMES THE RISK OF PERSONAL INJURY, PROPERTY DAMAGE, DOG'S INJURY OR DEATH AND WRONGFUL DEATH UPON HIMSELF/HERSELF.**
- 7) Paw Power Blues Dog Club requires that all dogs, over the age of 3 months, be vaccinated in accordance with Indiana State Law. The undersigned agrees to provide a copy of certificate upon request.
