Staying Safe – Following Best Practices

Paw Power Blues Dog Club will be following safety guidelines and following the local health authority guidelines.

- Please practice social distancing at all times.
- Consider wearing a facial mask when in close proximity to others.
- Consider wearing disposable gloves
- Hand sanitizer and disinfectant wipes are available in the training building, please make use of them to wipe down equipment and surfaces.
- Wash hands frequently.
- Refrain from shaking hands and touching dogs.

To maintain social distancing – Lunch will not be available for exhibitors.

Coffee, water and soda will be available for purchase.

We encourage exhibitors to bring their own lunch. There are several fast food restaurants in the Lowell and Cedar Lark area, within a few miles of the building.

- 1) ALL DOGS MUST BE ON LEASH OUTSIDE OF THE BUILDING. (Lake County ordinance)
- 2) DOGS ARE TO BE EXERCISED **ONLY** IN DESIGNATED AREA. (East side of the building)
- 3) PLEASE PICK UP AFTER YOUR DOG. (Clean-up materials are available)
- 4) ABSOLUTELY NO ALCOHOLIC BEVERAGES OR UN-PRESCRIBED DRUGS WILL BE ALLOWED ON THE GROUNDS OR WHILE PARTICIPATING IN THE EVENTS OR IN THE BUILDING ON THE DAY OF A UKC LICENSED EVENT
- 5) NO SMOKING IN THE BUILDING.
- 6) The U.K.C. and Paw Power Blues Dog Club are not responsible for loss, accidents or theft.

All dogs in attendance at any Paw Power Blues trial should be in compliance with state law and proof of rabies certificate should be available upon request.
